

## **PRIVACY POLICY**

In compliance with the provisions of data protection legislation, you are informed that:

1. Personal data which may be included in your candidacy will be held in a file in the name of Ferrovial S.A. (henceforth FERROVIAL), with registered business address at 28002 Madrid, Calle Príncipe de Vergara 135 and CIF [business tax ID] A-81939209.

The aim of this is to process the Participants' corresponding candidacies for the "Ferrovial Innovation Award" and, where the case may be, register any intellectual or industrial property rights regarding the Project.

The legitimacy of the processing of your data is based on the legitimate interest of Ferrovial S.A. in relation to the aims mentioned. The data provided shall be conserved throughout the development of said programme and for the years necessary to fulfil legal obligations.

Similarly, you are informed of the granting of personal data to Ferrovial Participant Companies, as defined in these terms, with the aim indicated in the previous paragraph. You have the right to access, rectify, delete or transfer, limit or oppose the processing of your data in certain cases, and to revoke your consent, where provided, through the issuing of a communication to the above stated address, including your name, surnames, a copy of your National Identification Document, an address for the purpose of notifications and the right you wish to exercise. Similarly, you may lodge a claim before the Spanish Data Protection Agency, in particular where you have not been satisfied in the exercise of your rights.

2. You warrant that the data provided is true, exact, complete and current, and you accept liability for any harm, direct or indirect, that may arise as a result of breach of this obligation. In the event that the data provided belongs to a third party, you warrant that you have informed such party of the content of this document and that you have obtained the corresponding authorisation to provide their data to FERROVIAL for the aforementioned purposes.
3. In the case of personal data collected through forms provided for this purpose on the Website, you must complete at least the fields marked with an asterisk; if that compulsory data is not provided, FERROVIAL will be unable to accept and manage your requests or queries on the Website.
4. As a result of FERROVIAL's concern about guaranteeing the security and confidentiality of your data, the necessary levels of security for the protection of personal data have been adopted and technical measures have been employed to avoid, as far as possible, any loss, misuse, alteration, unauthorised access and/or

## **COOKIE POLICY**

### **1. What are cookies?**

A cookie is a small data file that is downloaded to your device (computer, smartphone or tablet) when you access a website and allows the owner of the site to store or recover information about how you browse.

FERROVIAL wants to provide you with the necessary information about the cookies used on our Website to enable you to make a fully informed decision regarding their use and with respect to the protection of your privacy.

### **2. What kind of cookies does this Website use?**

This Website uses cookies to enable, customise and analyse browsing while improving the quality of services offered through this Website.

The cookies used are classified into several categories, although a cookie may be included in more than one category:

**Session cookies:** temporary cookies that are not stored on your machine and are erased at the end of the browsing session.

**Persistent cookies:** stored on the user's computer and are not deleted when the browser is closed.

**First-party cookies:** cookies sent to your device from our Website.

**Third-party cookies:** cookies sent to your device from a domain that is managed not by FERROVIAL but by another entity that uses the data obtained from the cookies.

**Technical cookies:** enable navigation through our Website and the use of its options or services, such as controlling traffic and data communication, identifying the session, accessing restricted areas or using security features during browsing.

**Personalisation cookies:** allow you to access our Website with certain predefined characteristics as a function of criteria such as language, browser type or the region from which you access the service.

**Analytical cookies:** used to monitor and analyse user behaviour. This type of cookie allows us to measure the activity on our Website using aggregated or statistical information about browsing habits. This Website uses analytical cookies, some of which are provided by Google Analytics (**advertising cookies:** are those that allow for the most efficient management possible of the advertising spaces on a website, adapting the content of the publicity to the content of the service request or the use of the web page. For this, the users' internet browsing habits are analysed and advertising is shown that is related to their browsing profile. Third parties such as Google Inc. may install this type of cookies.

During future visits to our Website, the user may consult this Policy by clicking on the corresponding link. If you wish to withdraw your consent at any time regarding the cookies on our Website, you must delete the cookies stored on your device and change your web browser settings. However, please note that if you disable or delete cookies, some features, services and content of our Website may be affected.
